Statement of Compliance with the Open Meeting Act, we have a quorum agenda was filed & posted October 27, 2022 @ 3:00 p.m. the ideas for each office have been turned in for each office's security plan, Roberts has added an area connecting with Judge Kirksey's office changes will be happening soon. There are quite a few items around the courthouse that have been junked or need to be junked T. White offered to bring a bobtail up to courthouse in order to haul junked items to the dump. Review was done on implementation of the 3% raise Mitchell spoke up & said he did not give his employees the retroactive raise because of lack of funds T. White explained to Mitchell that the board is trying to build up the use tax fund & the raises were included in the budget the board is willing to help the sheriff funds if they need repairs or emergency situations, the board just took into account that there was \$295,000 worth of funds that were not used in the sheriff's funds account B-7 Mitchell stated he is fine with that plan. Reporting accruals of leave balances to county clerk's office all elected officials have agreed to prepare some kind of spread sheet to report their employee accruals to the county clerk's office. Employee work schedules, Auditors have reported in the findings for our audit fiscal year ending June 2021 that worked hours must

match reported retirement hours as per the handbook all elected officials have agreed that their employees do work the 8 hours reported to Oklahoma Employees Retirement System either by skipping their 15minute breaks every day with a 30-minute lunch hour or coming to work at 8:30 a.m. review of documentation records of annual inventory review auditors reported that all offices must go thru their list of inventory items & check & sign off on the inventory sheet before June 30th of each fiscal year, it was agreed by all elected officials that they will follow the auditor's recommendations. Review purchase order processes for all offices, it was suggested that all offices have the purchasing agent prepare all purchase orders in order to have the requestion prepared in a timely manner & keeping closer tabs on correct information on purchase orders. Mitchell reported that his secretary does his purchase orders but Mitchell is willing to think about having the purchasing agent prepare his purchase orders. Regarding establishing employee performance evaluations pursuant to HB3085 C. White reported this would be a good way to give a good faithful employee a bonus for their performance, elected officials thought 10% was kind of steep but C. White reported that the amount can be adjusted, another question was what account would the funds come from for the bonus, C. White suggested maybe a cash fund or build the amount in your budget. Discussion regarding safety bonus Resolution R-22-67 to include all county employees 75% attendance of safety meetings in order to get the safety bonus was not passed T White stated the attendance did not matter for the safety bonus, he felt if you are going to give them a bonus give it to the employees, it was also discussed what accounts the bonus can be taken out of C. White reported some have cash funds or it can be budgeted. A resolution will be prepared at a later time addressing the safety bonus. As there was no other business before the board at this time a motion was made by T. White to adjourn seconded by Thorn Voting: All Ayes.
