As we've previously shared, while we had hoped for an earlier special election, state law does not allow for one until the 2026 election cycle. We want to emphasize that each of these applicants would be more than qualified to run for this office at that time, & we hope to see their continued involvement in public service., We also want to thank the community for your engagement throughout this process—your letters, phone calls, & messages were received, read, & genuinely considered as part of our decision-making. The individual selected for this appointment will not officially assume office until after the official retirement of Sheriff Kevin Mitchell, which is scheduled for June 30th. At that time, they will be formally appointed to serve until the certification of the
