Land also presented that the phones we now have come to the end of their life, commissioners could choose doing a \$6.50 charge per phone for 91 phones business faxes & 9 fax machines & \$24.50 per line per month which would be a total of over \$15,000 instead of this option it was decided to purchase the Alink phones because you can purchase a lot of phones for \$15,000 if they need to be replaced these purchased phones would cost \$25.65 per month per phone for services each month Motion was made by C.
