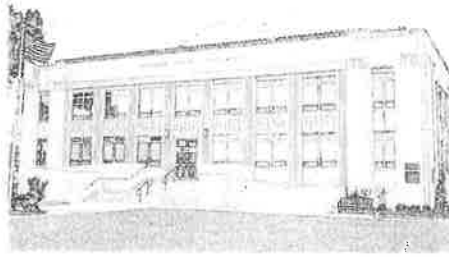

Minutes of the Woodward County Commissioners Special Meeting Monday, September 22, 2025, at 10:00 a.m. at the fairgrounds. Meeting was called to order by Chairman Clint White with Vice-Chairman Donny Thorn & Member Troy White present. Also, present were Wendy Dunlap, Ben Smith, Kelly Witchey, Tom Lucas, Bailey Kafka & Rameses Alvarez. Statement of Compliance was acknowledged we have a quorum agenda was filed & posted September 18th, 2025 @ 10:00 a.m. Invocation followed by Pledge of Allegiance to the United States of America. Motion was made by Thorn to approve the minutes of the previous meetings seconded by T. White Voting: all ayes. C. White reported that we should be moving back to courthouse starting September 15th, Witchey reported State is coming checking on programs NOY. Kafka reported we have received 3 different grant amounts for Art Council 1st -\$4000, 2nd -\$3500 & 3rd -\$3500 & people attended the fair from 30 different zip codes. Lucas reported Rural Development news listed eleven programs that are available in infrastructure & community & economic development categories, Industrial Access Program through ODOT was not funded by legislature this year, if oil & gas activity is the reason for the condition of the roads, there is Municipal Road Drilling Activity Fund, with a cap of \$500,000 for road damage with a \$25% match is required, US Census estimates Woodward County's 2025 population is 19,811 which is down from last year 68 people likely due to the close of the Ft Supply prison.
